

**REPORT ON REQUESTS MADE TO JOINT OPERATIONS CENTRE  
(J.O.C.) FOR THE PERIOD 1 JULY 2008 – 31 JULY 2008**

**PREAMBLE**

As TAC Site Assessors went around the various refugee sites, they were given requests for assistance by the inhabitants and these were categorized under food, child care, toiletries, bedding, health, general and legal. These requests were subsequently forwarded to JOC for processing.

Before submission to JOC, requests were vetted by TAC, based on criteria such as practicality, suitability and financial considerations as well as existing logistical agreements.

*Food* requests varied from site to site and were entertained where sites were receiving no supplies from Government, or were receiving insufficient quantities or there was need to vary the diet. *Childcare* included items such as formulae milk, cereals, baby supplements and nappies. *Toiletries* mainly covered soap, detergents, lotions and toothpaste. *Bedding* included mattresses and blankets. *Health* issues were channelled through regional civil society liaison personnel who in turn contacted the relevant City and Provincial medical officials. *General* requests included items such as brooms, showers, chemical toilets, buckets and basins among others. *Legal* issues were initially tabled but were later decided to be more appropriately covered under other remits.

### **HANDLING PROCEDURE**

Each request was faxed through to JOC and a phone call made to the appropriate people to confirm receipt of the fax and in all instances, such confirmation was given. We would be informed that the request had been logged in with their Social Development section for processing. Follow-ups were made on a daily basis. The content of all telephonic discussions, as well as dates, times and contact people, were duly documented in the JOC file.

### **OUTCOME**

Throughout the 31 day period under investigation, not a single request was met, including urgent ones such as formulae milk for babies. The standard response from JOC was, and continues to be, that they were still verifying and processing. On many of the instances, TAC has had to step in with its own supplies to avert a crisis.
